Open with Prayer - The meeting began by praying the scripture Jeremiah 1: 4-8.

Moderator's Report – Julia introduced and welcomed the incoming Elders and encouraged all Elders to commit to attending their Strategy Team meetings.

Consent agenda and Clerk's Report - A motion was made to amend the November 2023 minutes on page 5 to update the amount raised by the golf tournament from \$20,000 to \$27,000. The motion was seconded and approved. Elders were urged to complete the Conflict of Interest forms online.

We are still receiving pledges. Covenant partners have pledged \$1.6 million compared to \$1.7 million last year. These pledges comprise 55% of the annual operating budget.

Chair Cathy Finck presented a recommendation to approve the roster of 2024 Strategy Team assignments for the lay members. It was seconded and approved. The team is preparing an officer recruitment class on April 7 to explain leadership at Grace. It's a prelude to the Church Officer Nominating process.
