Call Meeting to Order - Rev. Julia Leeth

Open with Prayer – The meeting opened with communal responsive prayer using Acts 11:21-26 led by Rev. Julia Leeth.

Moderator's Report – Julia called on Rev Chris French, who announced an upcoming event. Chris announced that the Margaret Jarboe Lectureship Series Committee has approved funding for a guest lecturer on September 11 to kick off the Fall season of Equip. The Fall Equipping class will focus on making sense of your Bible: Cultivating a Cover to Cover Faith. Currently, Andrew serves as Senior Pastor of Mandarin Presbyterian Church in Jacksonville, Florida.

Consent agenda and Clerk's Report – A motion was made to approve the Consent agenda. The motion was seconded and then approved.

New Business -

Team Updates:

Ministry Support: Elder Lisa Descant reported that financials for May will close at an increased deficit – actual is \$1.2 million against a projection of \$720,000, mainly attributable to lower than projected revenue. The monthly report is attached.

5:10:5 Plan – Elder Andy Frazelle emphasized that it is important for elders to make the actual 5:10:5 pledge online or by pledge card, not to merely increase the annual giving. There has been some confusion around this. Elders had done it both ways. Julia asked that elders complete a 5:10:5 pledge card before the next Session meeting – August 28.

FY2024-2025 annual budget: Lisa presented and explained the proposed annual budget for FY2024-2025. The budget shows an annual projected deficit of \$1.12 million, and \$2.5 million on hand. After discussion, there was a motion to approve next year's budget for \$3,796,983. It was seconded and approved unanimously before the beginning of the fiscal year.

Leadership Development: Elder Nnenna Akwari strongly encouraged the elders to prayerfully consider who they would nominate for elder and deacon roles.

There was a motion to move into Executive Session. It was seconded and approved.

After returning from Executive Session, there was a motion to authorize a task force to develop a plan for Grace Church to more equitably share the capital cost of the School with Grace School. A vote was called, and the motion was approved unanimously.
