Ministry Support: June revenue was encouraging, leading to a 42% increase over June 2023. FYTD revenue was 3% less than 2023. Operating results showed a surplus for the month compared to 2023. The FYTD deficit is \$1.08 million, which is greater than budgeted for the month and the fiscal year. Also, see the attached monthly report.

Leadership Development: Chair, Cathy Finck, presented the roster of elder nominees for the Class of 2027, as well as nominees for the Lay members of the Church Officer Nominating Committee, Class of 2027. Grace School: The school moved into its new facilities over the summer. Students began classes on August 15. There are 502 students from 347 families and 97 staff this semester. Also see the monthly report.
