Strategy Team Updates

Ministry Support – Chair Lisa Descant reported that the fiscal year deficit is \$159,332 lower than budgeted, due to reduced operating expenses. See the monthly report for details.

Worship -The team has not met yet this quarter.

Equip – See the monthly report. Sue McGown reported that Grace will begin an all-church Bible Project this fall. We will all read the entire Bible together, beginning in September. It will be the subject for preaching and teaching.

Serve – Chair Tom Lee reported that several members of Grace attended the grand opening of Camden Park. The upcoming work trip to North Carolina has been rescheduled for May 26-30. There is space for 15 and 7 have signed up so far. The cost is \$400, including housing, meals, tools, and supervision.

Grace School – Chair Karen Welton presented a motion to approve allocation of \$460,000 to rebuild the playground for the Lower School. The motion was approved. The annual gala raised \$530,000. See the monthly report.

Leadership Development – Chair Nnenna reported that the Church Officer Nominating Committee has begun the process of searching for 6 Elders and 17 Deacons. Nominations are open through May 15.
